A payment of \$72.00 is due on the 22nd of every month starting in September. The final payment is due on or before February 22nd, 2020. Gratuity and insurance are not included.

Interior 4B Cabin (8 Cabins Held) 2 people cabin: Cost per person is \$485.52. A \$50 deposit is due by August 22nd. The remaining balance is \$435.52. A payment of \$73.00 is due on or before the 22nd of every month starting in September. The final payment is due on or before February 22nd, 2020. Gratuity and insurance are not included.

Interior Room 4C (4 Rooms Held) 2 people per room: Cost per person is \$487.52. A \$50 deposit per person is due on August 22nd. The remaining balance is \$437.52 which is due on or before the 22nd of every month beginning in August. A payment of \$73.00 is due on or before the 22nd of every month starting in September. The final payment is due on or before February 22nd, 2020. **Gratuity and insurance are not included.**

Interior Room 4D (4 Rooms Held) 2 people per room: Cost per person is \$492.52. A \$50 deposit per person is due on August 22nd. The remaining balance is \$442.52 which is due on or before the 22nd of every month beginning in September. A payment of \$74.00 is due on or before the 22nd of every month starting in September. The final payment is due on or before February 22nd, 2020. **Gratuity and insurance are not included.**
