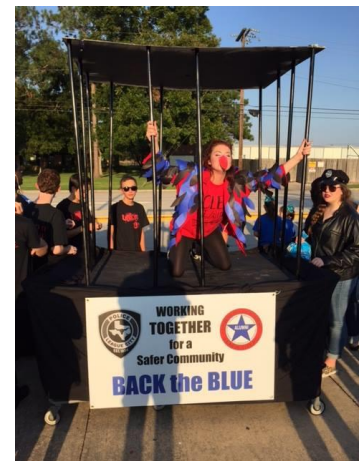


League City Host Region 1 October Meeting

Officer O'Neal with son

Officer Daniel O'Neal has been a police officer for 10 years and 2 months. He was employed with the Dickinson Police Department for 8 ½ years and hired by the League City Police Department in December of 2013. Officer O'Neal has acquired his Field Training Officer Certificate and Basic Instructor's Certificate as well as his Advanced Police Officer Certificate. He is bicycle patrol certified and is currently a member of the Patrol Division, Bike Team and Honor Guard. Officer O'Neal is married and has a 4 year old son.

Officer John Williams has been a police officer for 5 years having started his career with the League City Police Department in September of 2010. Prior to being employed with LCPD, he served in the Marine Corps where he was deployed to Iraq in 2008 and honorably discharged with the rank Sergeant in 2009. Officer Williams has been assigned to the Patrol Division for the past 5 years. He is married and has 2 children.

On Saturday, August 29th Officers O'Neal and Williams were dispatched to the Kroger grocery store located at West Main and Gulf Freeway in reference to an alleged male subject soliciting other shoppers for money. The alleged subject was accompanied by a male juvenile who was sitting in a vehicle outside of the store. When questioned by the Officers, the juvenile explained that it was his father, after having recently lost his job, who was inside asking other shoppers for money so that he could buy groceries. Officers O'Neal and Williams then questioned the gentleman when he exited the store. The gentleman explained that he had recently lost his job and that he, his wife and their 6 children were now living in a hotel room. He further explained that after the hotel expense and the purchase of school supplies for his children there was nothing left of what little money he had for groceries. Officers O'Neal and Williams then escorted the gentleman back into Kroger where they advised him to shop for what he needed and subsequently paid for the approximately \$60 worth of groceries and diapers out of their own pockets. They then walked with the gentleman back to his vehicle and waiting son where the gentleman thanked them and departed the area.
