November 2015 Officer of the Month Detective Scott Aldridge

Detective Scott Aldridge has been in law enforcement for twenty-two years and currently holds his Master Police Officers License. Det. Aldridge began his career with the League City Police department in 2003 as a patrol Officer. He was assigned to CID (detective) in 2007. While he works an array of crimes, his main focus is on residential burglaries, vehicle burglaries and stolen vehicles.

On 09-08-15 at approximately 2:45 A.M. Det. Aldridge was called out to the First Choice Emergency Room located at 3016 W. Marina Bay Drive. He was advised that a robbery at gunpoint had taken place and an unknown amount of narcotics had been stolen. During the investigation of this crime another robbery at gunpoint took place at approximately 8:30 A.M. that included a stolen vehicle. LCPD Officers located the vehicle and a pursuit ensued. Det. Aldridge followed the pursuit until the vehicle crashed into the Walgreens in Kemah. The suspect fled into the Walgreen and began shooting in an unknown direction. Det. Aldridge observed the crash and immediately went to the rear of the Walgreens anticipating the suspect would attempt to escape. He then began to utilize LCPD and Kemah Officers and place them in tactical position until SWAT could arrive and take over the scene.
