March 2016 Officer of the Month

Detective Angie Strachan



Detective Angie Strachan began her police career with the League City Police Department in 1996 as an intern. She then became a detention officer and, in 1998, she was sworn in as a Police Officer. Detective Strachan has been a member of the Hostage Negotiation Team since 2006. She worked as a patrol officer until transferring to the Criminal Investigation Division in 2013 as a member of the Crime Suppression Unit (CSU). She is married to Officer Matt Strachan who serves in the Traffic Division at LCPD and has two children, a daughter and a son.

The CSU is responsible for the investigation of cases that directly affect the quality of life in League City such as narcotics, patterned crime sprees, and other various criminal activities. Detective Strachan credits the success of the CSU to the dedication of each team member and their desire to serve the public. The CSU is led by Sergeant Stephen Antley and includes Detectives Yates, Yount, Knowlton, and Kifer. Recently, the CSU completed two successful investigations. The first is a case against the 777 Game Room for alleged gambling operations and the other is against seven different "massage" parlors for alleged prostitution activities. The combined efforts of the team led to several arrests, seizure of property, and eventually the closure of one game room and six "massage" establishments.

SGT Antley provided the following statement: "Detective Strachan was one of two undercover detectives with the unit used to build the case against the 777 Game Room. She coordinated all efforts with outside agencies (i.e. Comptroller's Office) and has been responsible for keeping in touch with the DA's officer for the pending seizures. When the original investigating detective went out for surgery, Detective Strachan stepped up and helped to successfully complete the investigation.

During the massage parlor operations, Detective Strachan was, by far, the most organized and thorough detective in the unit. She coordinated with the Texas Health Department and was able to build a professional relationship with someone she could call directly with any questions. Even though seven different massage parlors were under investigation, Detective Strachan kept everything organized and in-line so leadership could readily make sense of it. During inspections of the establishments, Detective Strachan would take charge and complete all of the required and necessary paperwork, all while keeping it organized. Even though it was a time-consuming effort by the entire unit, it definitely would not have been as successful without Detective Strachan."

For her service and dedication to the City of League City Detective Strachan will be presented a plaque and a gift at the Alumni general meeting on Thursday, March 10th.
