Houston PD Encourages Everyone to Have a Safe Holiday

The next few weeks will be a busy time for everyone and while we might be distracted with the hustle of the holiday season, HPD wants everyone to remember a few simple tips that will help you and your family stay safe.

While shopping you should stay alert to your surroundings.

- Don't walk and talk on your phone and only carry what cards and cash are necessary.
- Secure your belongings out of sight and keep your purse nearby at all times.

The holiday season also means increased spending so be careful to protect your personal data.

- Be wary of who you provide your personal information to and watch for credit skimming devices.
- Watch your financial statements closely and report inconsistencies immediately.

When you make your holiday purchases, stow them in the trunk prior to your next destination.

 If you are stowing packages in your trunk and then heading back in to keep shopping, move your vehicle and park in a different place.



- Make your most expensive purchase your last purchase of the day and take the item straight home.
- Criminals are watching what you are buying and whether you are going to leave it unattended in your car after you make your purchase.

Don't forget to protect your home

- At home keep the outside well lit, doors locked and curtains closed.
- If you are traveling out of town have a neighbor watch your house and put your lights on a timer.

The top 10 things to do while in El Paso

There's no better way to explore El Paso than by taking advantage of the various attractions, events, and recreational activities happening throughout the city, every single day. Whether you're here for business or vacation travel, you'll never be bored with so many things to do in El Paso!

Concordia Cemetery: Concordia is the resting place for over 60, 000 historical citizens and early pioneers of El Paso and Juarez. John Wesley Hardin, Reverend Joseph Tayes, the Mundeay family, Lawman John Selman and many more are forever residents of Concordia.

Downtown Walking Tour: This self-guided walking tour (about 90 minutes) begins in the southwest corner of San Jacinto Plaza, at the 1910 E. Howard post clock. The tour takes you on a stroll to historic architectural landmarks and sites, some noted with historical markers.

El Paso Zoo: Bigger and better than ever, the El Paso Zoo is an expansive green space that is

home to exotic animals from around the world and features family attractions such as the African Star train and the Hunt Family Desert Spring. The El Paso Zoo is Accredited by the Association of Zoos & Aquariums (AZA.)

Franklin Mountains State Park: Towering above the city of El Paso is the Franklin Mountains State Park, the largest state park in an urban setting. Here you can hike, bike, climb, or run rugged terrain in 37 square miles of desert wilderness, scrub vegetation and open space, with 125 miles of multi-use trails.

Historic Mission Trail: This Trail is rich in history dating back 400 years. Sure to take your breath away these three adobe churches remain as living testaments to the faith of our Spanish and Indian ancestors.

Hueco Tanks State Historic Site: Hueco Tanks, one of the most historical sites in Texas, because of its pictographs and its use as a stagecoach stop along the old Butterfield Trail, is a haven for rock climbers from around the world. Climbing, hiking, rock art, and birding tours are held regularly.

Magoffin Home State Historic Site: A striking 1875 adobe structure, Magoffin Home State Historic Site explores the stories of a multicultural family who actively participated in U.S. expansion and settlement, military service, trade on the Santa Fe—Chihuahua Trail, Civil War turmoil, and U.S.—Mexico relations.

Museums: Downtown is home to 4 museums, all within walking distance. These include the Holocaust, Art, History, and El Paso Exploreum. Transmountain road is home to two very unique museums. The Archaeology which depicts the story of the first inhabitants of the El Paso area, and the Border Patrol, the only one of its kind in the Nation.

Wyler Aerial Tramway: Take a ride on an aerial cable car and enjoy a 7,000 square miles view that encompasses three states and two nations. The tramway ride is a memorable experience offering a vista of the vastness and stark beauty of the southwest.

Vineyards: With over 300 sunny days a year we're bound to have

the finest regional vineyards. La Vina Winery and Zin Valle Vineyards are located along the historic HWY 28.



What's the weather like?

It's rare to have a day in El Paso, summer or winter, when the sun does not shine. In fact, it shines over 300 days a year! Winters are mild with an average daytime temperature of 60 degrees F and an average low of 35 degrees F. Summers are warm and dry with an average daytime temperature of 95 degrees F in June, July, and August. When you consider the five months, May through September, the average daytime temperature is 91 degrees F. On average El Paso receives 9 inches of rain fall each year.

Cold Weather? "Not here!" (yet)

Even though we may not have cold snowy conditions here in southeast Texas, you may drive into those climates that do get that way. The following is from the Red Cross as you might suspect when you read these. These are good tips.

- 1. Prepare your vehicle for traveling to grandmother's house. Build an emergency kit and include items such as blankets or sleeping bags, jumper cables, fire extinguisher, compass and road maps, shovel, tire repair kit and pump, extra clothing, flares, and a tow rope.
- 2. Drive your sleigh and reindeer safely. Avoid driving in a storm. If you must travel, let someone know where you are going, the route you're taking to get there, and when you expect to arrive. If the car gets stuck along the way, help can be sent along your predetermined route.
- 3. Help prevent the spread of the flu. Stay home if you're sick. Wash hands with soap and water as often as possible, or use an alcohol-based hand rub. Cover your nose and mouth with a tissue or sleeve when coughing or sneezing, and throw the tissue away after use. If a tissue isn't available, cough or sneeze into your elbow, not your hands.
- 4. Follow Santa's fashion lead dress in layers. When it's cold outside, layered lightweight clothing will keep you warmer than a single heavy coat. Gloves and a hat will prevent loss of body heat. Cover your mouth to protect your lungs.
- 5. Use a Red Cross-trained babysitter when attending holiday festivities. Red Cross-certified babysitters learn to administer basic first aid; properly hold and feed a child; take emergency action when needed and monitor safe play. Some may be certified in Infant and Child CPR.
- 6. Avoid danger while roasting chestnuts on an open fire. Stay in the kitchen when frying, grilling or broiling food. If you leave the kitchen even for a short period of time, turn off the stove. Remember, unattended cooking causes most kitchen fires
- 7. Be a lifesaver during the holidays. The Red Cross recommends at least one person in every household should take first aid and CPR/AED training. Visit www.redcross.org/take-a-class for details.
- 8. Designate a driver or skip the holiday cheer. Buckle up, slow down, don't drive impaired. If you plan on drinking, designate a driver who won't drink.
- 9. When the weather outside is frightful, heat your home safely. Never use your stove or oven to heat your home. Never leave portable heaters or fireplaces unattended. Install smoke alarms.
- 10. Cut down on your heating bills without being a Grinch. Get your furnace cleaned and change the filters. Make sure your furniture isn't blocking the heat vents. Close off any rooms not in use and turn off the heat in those rooms. Turn down the thermostat and put on a sweater.
- 11. Going home for the holidays? Travel safely. Check the air pressure in your tires and make sure you have windshield fluid. Be well rested and alert. Give your full attention to the road avoid distractions such as cell phones. If you have car trouble, pull off the road as far as possible.

Less Lethal

Editor's note: This is not an endorsement of a product, but is presented as information only.

I happened to drop by the Police Station an hour early on my day for school traffic last month. I needed to talk with Chris Jackson about something, but I can't remember what it was right now. I noticed a van in the parking lot with the words "Less Lethal" in large letters written on the side? I walked into his office and he said he didn't have time to talk as he was headed to the Training Room for a demo; and he asked if I'd like to come. Well I still had an hour to kill, so I went to listen. It was quite interesting; it was a demonstration of a new product called the JPX Pepper Gun.

It resembles a firearm, but could be mistaken for a toy pistol. Of course, if it was pointed at you, it would look quite menacing; especially if the person aiming it wore a blue uniform and a badge. We watched a video and listened to the sales representatives, as well as got to actually fire and reload the weapon (it didn't have a payload, it was like shooting blanks). They explained that the JPX Pepper Gun was the most functional and powerful hand-held OC delivery system (OC Pepper Spray) available today. The OC is the irritant, OC stands for oleoresin capsicum. The gun uses revolutionary Piexon cartridge based propulsion technology. It effectively reaches distances up to 23 feet at 405 MPH. It will reach further, but the product will disperse in a wider pattern than is optimal and the MPH will also lessen with an increase in distance. The pattern is subject-specific with 1 foot of spread at 15 feet (just a bit over 1 foot at 23 feet). The OC Pepper Spray used is twice the strength of the pepper spray currently used by BPD and twice the strength of most conventional pressurized OC canisters.

Throughout the demo, the pepper gun was compared to the Taser; as it is in direct competition with it. The "Tasers" shortcomings were exploited and the pepper guns superiority was touted. Of course, that's to be expected when the company's salesman is talking. However, everyone in the room was saying how you have to keep a Taser dry, it has to be charged, it can't be reloaded easily, you only get one shot, you have to get certified to use it, it is very expensive; and the big one – there have been lots of deaths attributed to them. The pepper gun is less expensive, it has yet to not bring down a suspect, training is simple and no certification is required, it is easily reloaded, you have 2 shots per load, it can get wet, there are no batteries required for it to operate, no electronics to fail, and a few more things that I have forgotten.

Well I didn't want to sound like an advertisement, but it seems like a good product. There was serious talk about switching to pepper guns and phasing out Tasers; but I think that may have gone by the wayside. Perhaps it will be revisited at a later date. The Chief mentioned that he was going to see if we could get issued pepper spray, but I haven't heard what happened with that. This pepper gun sounds good to me; after all its just pepper spray! 
Mary Malm received a Silver Pin & certificate from Sgt. Jess Colwell for having over 500 volunteer hours.






